#### **CIRCULAR**

In accordance with the provisions of Clause (II) rule 18(1) of the CCS (Conduct) Rules, 1964, every Government servant holding Group "A" or "B" post is required to submit an annual return giving full particulars regarding the immovable property inherited or owned or acquired by him or held on lease or mortgage either in his own name or in the name of any member of his family. The statement for each year has to be furnished by 31st January of the following year. As per the DOPT O.M. No. 11012/11/2007-Estt. dated 27th September, 2011, the Vigilance clearance shall be denied to an officer if he fails to submit his annual immovable property return of the previous year as required under rule within the stipulated date.

All Heads of Divisions/PCs/Section In-charges are, therefore, requested to bring the contents of this letter to the notice of all Group "A" and "B" officers/officials working under their control for furnishing the Immovable Property Returns in the enclosed proforma (overleaf) for the year 2019 (as on 01.01.2020) to this office within the stipulated date i.e. 31.01.2020.

While furnishing the return, the phrases such as 'same as previous year' or 'no change' are not to be used and full particulars of the immovable property inherited/owned/acquired or held are furnished.
