- 2. Toll tax, parking charges etc. will be borne by the firm.
- Valid service tax registration certificate may be furnished; rate quoted 3. should be inclusive of Service Tax/Other applicable Taxes.
- Authorized registration certification of the firm may be attached. 4.
- 5. The registration Nos. and valid papers which include insurance, registration of vehicle should be kept in the vehicle to be provided.

- 7. Cleanliness condition of the vehicle should be excellent. The driver should be in neat and clean uniform, well behaved & should have valid license. The driver in drunken condition should not be deputed for driving.
- 8. The vehicle should not be more than three year old.
- 9. Penalty etc. imposed by traffic police department will not be paid by the Institute.

- 10. The vehicles so requisitioned should be made available in time and at short notice otherwise the contract is likely to be cancelled, without assigning any reason and EMD and security deposit will be forfeited.
- 11. Copy of PAN/TIN/Service tax no. of the firm should be attached with quotation.
- 12. <u>Tender Fee:</u> An amount of Rs. 500/- (Rupees Five Hundred only) as Tender Fee in the form of DD/Bank's cheque drawn in f/o ICAR Unit-IISS, Bhopal should be enclosed while submitting the quotations.

In case the tender is terminated, the security deposit shall be forfeited.
