### 2. Forms of EMD and PBG

## **Additional Terms & Conditions**

1. Service provider is required to pay salaries / wages of contracted staff deployed at buyer location first i.e on their own by transfer of wages to their bank A/C by 7th day of succeeding month and then claim payment from buyer along with all statutory documents like Proof of payment of wages, EPF, ESI, GST etc, Form - B of minimum wage register as well as the bank statement of payment done to staff.
2. **Penalty Clause:**
  - a. In case of failure to make payment of wages to contractual staff by 10<sup>th</sup> day of the succeeding month, penalty @Rs. 500/- per day can be imposed.
  - b. In case of non-deposit of EPF/ESI/GST by the 15<sup>th</sup> day of the succeeding month additional penalty @Rs. 500/- per day can be imposed.
  - c. In case of loss / damage to the property of the buyer is occurred, the same shall be recovered from the bill of the contractor.
3. **Payment to the contractor:** After making payment of wages to the workers and depositing of EPF/ESI/GST etc., the contractor will raise the bill along with details of wages and proof of payment of wages in the bank A/c of the workers and copy of challans / receipts of deposit of EPF/ESI/GST with details by the 20<sup>th</sup> day of the succeeding month. Payment of bill shall be made by the buyer within 30 days of receipt of bill complete in all respects.
4. The guards should be allowed compulsory weekly off from duty. Additional relievers should be arranged for arranging round the clock security through out the year. No overtime duty should be taken from any guard.
