





This is issued with the approval of the Director I/c and is subject to ratification by the Director.







Sir,

I am directed to inform that Dr. Abhishek Rathore, Scientist of this Institute is on deputation as "Scientist (Biometrics) w.e.f. 27.06.2008 to till date at International Crops Research Institute for the Semi Arid Tropics (ICRISAT), Patancheru (A.P.) are having CPF system.

As per rule 10 of General Provident Fund (Central Services) Rules, 1960 in the case of a subscriber who is on deputation to a body corporate owned or controlled by Government such body will recover the subscription and forward the same to the Accounts Officer of parent Department (ICRISAT). It is the responsibility of the DDO of where official on deputation to deduct his salary deductions i.e. GPF, GSLIS and other Loans and Advances taken from parent office and to remit the same for proper accounting purpose. But ICRISAT has not forwarded any such deductions to IISS, Bhopal. Dr. Abhishek Rathore had himself issued cheques and prepared forwarding letters for depositing monthly GPF-Subscription, GSLIS contribution, HBA Installments, the same was objected by the A&A IISS, Bhopal (Copy enclosed).

As per Rule 4 and Note 1 there under of General Provident Fund (Central Services) Rules, 1960, all the employees who are not eligible for admission to the Contributory Provident Funds, are required to subscribe to GPF. All the Central Government employees who were governed by old pension scheme under the Central Civil Services (Pension) Rules 1972 will be eligible for pensionary benefits for the services rendered to the Government as per rule.

Dr. Abhishek Rathore had personally remitted GPF monthly subscriptions by providing his personal cheques during his deputation period. Now vide letter dated 24.07.2013 he has remitted Cheque No. 17180 dated 03.07.2013 amounting to Rs.10,75,905/- towards Contributory Provident Funds received from ICRISAT to be deposited in his personal GPF Account. He is sending advance cheque for deduction of salary of Jan, 2014 in Dec. 2013 (Copy enclosed Annexure I & II)


As per rule one employee cannot operate two provident funds account at the same time. One GPF Account at IISS, Bhopal and another CPF Account at ICRISAT, Hyderabad. In CPF Account the Government contribute is 10% contribution in lieu of pension because of non pensionable employee. As government hold the responsibility of paying retirement benefits like pension, family pension, Death Gratuity, Retirement Gratuity, Service Gratuity, Commutation, Leave encashment etc. Then the portion of Employer contribution belongs to Government who undertakes to discharge the pensionary liability. As per rule the entire amount of CPF must be credited in the Government Account of for the deputation period. Further he is also not allowed to operate two provident funds schemes both at the same time.

In the case of foreign services the services in not rendered to Government but to a foreign employer, the pension liability cannot be met unless a pension contribution in the place of services to Government is recovered. Please see OM no. 28/30/2004-P&PW (B) dated 26.07.2005, OM No. 26/18/EV-B-/75 dated 08.04.1976 and OM no. 4/61/99/P&PW(B) dated 30.09.2000 for information. Dr. Abhishek Rathore had deposited LSPC amounting to Rs.192851/- for the period w.e.f. 27.06.2008 to 26.06.2011, he is requested to deposit LS&PC.




