

- Name of all contractual staff (RA/SRF/JRF/PA) terminated in and redeployed or their services were continued by amendments or by quashing the concern order in the institutes of ICAR during 2011-12 and 2012-13.
- Name of the terminated contractual staff (RA/SRF/JRF/PA) during 2011-13 in the continuing project and who have not been issued those services have not been made continued. Reasons for this disparity.
- Certified photocopies of letters, proceedings, corresponding note sheets for termination as well as continuation of services/deployment of each contractual staff during 1st April 2011 to 30th June, 2013.

The applicant further states that:

1. An IPO number 16 F 946765 dated 21/06/2013 amount rupees ten is enclosed herein, as per section 27(2) of RTI Act 2005.
2. If the information provided is delayed, false, and incomplete or the application rejected for malafide reasons, a penalty of maximum RS 25000 can be imposed.
3. The disobeying of law by a public servant, with intent to cause injury to any person is an offence u/s 156 of Indian Penal Code and attracts imprisonment of 1 year, or fine or both.
4. Framing of an incorrect document by public servant is an offence u/s 167 of Indian Penal Code and attracts imprisonment of 3 years, or fine or both.
